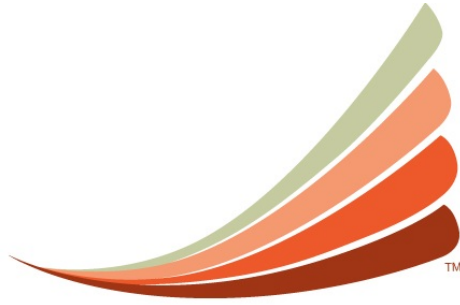

## Community Foundation Receives \$500,000 to Grow Local Grantmaking

Henry County Community Foundation has received a grant of \$500,000 as part of Lilly Endowment Inc.'s seventh phase of its Giving Indiana Funds for Tomorrow (GIFT) initiative. With GIFT VII, the Endowment is making up to \$125 million available to help Indiana community foundations strengthen the towns, cities and counties they serve.

Henry County Community Foundation is using this matching fund grant to build their financial assets and support their charitable activities. The Foundation's board of directors designated the matching fund grant to support the growth of Choose Henry Flex Fund unrestricted fund, which over time will provide flexibility to help the foundation to meet community needs. Lilly Endowment will provide \$2 for every \$1 contributed to the Choose Henry Flex Fund during the matching period, October 1, 2018, through December 31, 2020 or until match dollars reach \$500,000.
