Agape Learning Center is a Children's Daycare/ Educational Center serving Henry County children ages 6 weeks old through Kindergarten. Agape has been operating since 1977 and is the only state licensed building facility and educational center, as well as a Level 3 Paths to Quality available in Henry County. Being a very sought after educational center, Agape currently has 103 children enrolled as well as 93 on their waiting list. The continuing growth calls for a much needed expansion. The Choose Henry Flex Fund granted Agape Learning Center \$10,138.18 to aid in the expansion of the center.
