# Saving Lives with the Red Initiative

IN THE FRANTIC seconds after a traumatic injury, every moment counts. For victims of severe blood loss, the difference between life and death can hinge on immediate access to lifesaving blood transfusions. But in rural communities like Henry County, access to this critical resource can be limited, leaving patients vulnerable in their most desperate hours.

This is where donors to the Choose Henry Flex Fund are playing a vital role in bringing the revolutionary Red Initiative to Henry County.

Inspired by a similar program in New Orleans, Assistant Chief Justin Harrison and Captain Scott Rifner of the New Castle-Henry County EMS saw an opportunity to dramatically improve their ability to save lives.

The Red Initiative allows paramedics to carry and administer blood products directly on the scene. This is a game-changer in rural areas, where transporting patients to distant hospitals can be a matter of life and death. But implementing such a program comes with hefty upfront costs, putting it beyond reach for many smaller EMS agencies.

Recognizing the potential impact of the Red Initiative, the Grants Committee of the Foundation awarded a grant to the EMS, providing the essential funding to help purchase the field blood transfusion kit.

"This would have been a no-go without the Foundation," says Harrison. "Going forward would be rough to impossible without the help of the funds."

The impact of this program is clear and undeniable. Studies have shown that receiving blood within the first 36 minutes of a traumatic injury can increase the survival rate by a staggering 90%. With the Red Initiative, New Castle-Henry County EMS crews can now deliver that lifeline directly to patients in their moments of greatest need.

"People will survive traumatic injuries that otherwise would not have," says Rifner. "The sooner someone gets blood, the better the outcome." A system like this needs regular maintenance to continue offering life-saving services. This includes the consistent purchasing of blood bags. Fortunately for the EMS, there are two designated funds at the Foundation ready to help with a yearly payout. Learn more about these funds established by the estates of two generous women on pages 6-7.

New Castle - Henry County EMS' The Red Initiative is evidence of the power of community and generosity. It's a story of ordinary people coming together to make an extraordinary difference. And it's a story that wouldn't be possible without donors to the Choose Henry Flex Fund.

WHEN CORA FOUST AND EDITH SMITH created their wills in 1960 and 1979, they never could have dreamt of how pivotal their planned gift would be for Henry County.

The Red Initiative, mentioned previously in the opening story on page 4, is a ground-breaking technology. The first of its kind in Indiana, New Castle-Henry County EMS is now equipped with the ability to perform blood transfusions on site. No longer having to transfer people out of the county to receive blood, lives will be saved.

Though Cora and Edith would never set eyes on the leadingedge Red Initiative program that is being implemented with the New Castle - Henry County EMS, their foresight in crafting estate plans decades ago is a sustaining force for this lifesaving technology.

With payouts from their funds distributed yearly to the EMS, they will help supply the blood needed to carry on the work of this innovative program. Making their gifts from decades past the difference between life and death.

Their stories are powerful, and they are joined with many others in this provisional- forward thinking way of giving. Donors who have included the Foundation in their wills have found a way to ensure the causes they care most about will be strengthened long after they're gone. If you have, perhaps your thoughts have centered on ways you can leave an enduring legacy that reflects how you helped others and the good that you achieved during life. A **charitable bequest** is one of the easiest ways to help the causes you care about and make a strong legacy statement.

Legacy Giving

Did you know there are several different ways to leave a legacy gift to support the causes you care about? Here are some ways to include a charitable gift in your estate plan:

#### 🔁 WILL, TRUST OR CODICIL

You can leave a charitable bequest in your will, trust or codicil. Your gift can be any dollar amount, a specific asset, a percentage of your estate, or the residue of your estate.

#### BENEFICIARY DESIGNATION

You can use a beneficiary designation to leave a legacy gift. You can designate us as a beneficiary of a retirement plan, a financial account or a life insurance policy.

#### TESTAMENTARY PLANNED GIFT

You can even create a testamentary planned gift. You can fund a testamentary gift annuity or charitable trust to provide for family and support the causes you care about. Retirement assets are particularly good assets to use to achieve the best tax outcome with a testamentary planned gift.

#### HOW A CHARITABLE BEQUEST BENEFITS YOU

In addition to helping you create your legacy, a charitable bequest may benefit you and your family in several ways. Bequests are flexible, can help you set priorities and are easy to manage.

**Priorities** - With a bequest you can establish a priority as to who will inherit specific assets. If the primary beneficiary, such as a relative, is unable or unwilling to inherit the asset, you can name us as a contingent beneficiary.

**Easy to Manage -** With a bequest, such as a gift made as part of a beneficiary designation, you can easily manage changes to your plan. For example, many IRA administrators permit IRA owners to make beneficiary changes through their online accounts.

**Tax Savings -** With a bequest, you may even be able to reduce taxes on your heirs. If you give your high tax assets (such as your IRA) to us, you can leave your low or no tax assets (like a home or stock) to your family.

#### LIVING TRUST

A living trust holds your property and is managed by you or a trustee you select. You or your selected trustee may own, manage and control your assets during your lifetime. You may add property to or remove property from the trust at any time. Any trust income is taxable to you.

#### CUSTOM ESTATE PLAN FOR FAMILY BUSINESS, INVESTMENTS OR A CHILD WITH SPECIAL NEEDS

You may need a custom plan if you own a family business, have substantial real estate holdings or your child has special needs. A special needs trust will facilitate care of your child by providing resources and directions.

#### IRA, 401(K) OR OTHER RETIREMENT PLAN

IRA, 401(k), 403(b) or other retirement plan can be transferred to a person or charity after you pass away. It is transferred through a beneficiary designation form provided by your plan custodian. You may select a primary beneficiary as well as contingent beneficiaries.

#### LIFE INSURANCE

Life insurance involves a written document called a policy, which is a contract. The policy will provide a payout to the policy beneficiaries after the person whose life is insured passes away. Primary or contingent beneficiaries are named on your beneficiary designation form.

#### CHARITABLE REMAINDER TRUSTS

A charitable remainder trust (CRT) is an excellent way to benefit yourself, your spouse or other family members and provide financial support to your favorite charitable causes. A testamentary CRT through your will or living trust can provide income for your family. After all of the payments are made to family, the remaining trust assets will be given to charity. You may also consider funding a lifetime CRT. You will receive a charitable income tax deduction and trust income payouts.

#### CHARITABLE GIFT ANNUITIES

A charitable gift annuity is a contract involving you and a charity. You make a gift to the charity in exchange for fixed payments for the life of one or two persons. After all payments are completed, the charity receives a gift. A gift annuity funded during life provides you with a charitable income tax deduction and partly tax-free income.

#### DONOR ADVISED FUNDS

Many families find that a donor advised fund (DAF) is a simple and efficient way to support the causes they care about. With a DAF, you can time your gifts to favorite charities. You receive an income tax deduction and may decide later on your transfers to favorite charities. Many parents find that a DAF is a useful tool that can encourage philanthropy by allowing their children to recommend future gifts to charity from the DAF.

#### CHARITABLE ENDOWMENTS

You can use your will or trust to create an endowed fund after you pass away. We will invest your gift and use the annual income to support your chosen area of our work. Because we are not spending the principal amount of your gift, an endowed gift has the ability to benefit us for many years and it enables you to leave a lasting legacy.



# Thriving through Nature & Community Support

A VIBRANT COMMUNITY doesn't happen overnight. Organizations, volunteers, and leaders work tirelessly to provide a high quality of life. Groups like Healthy Communities of Henry County (HCHC) have had boots on the ground for many years, helping Henry County to become a place with bright natural spaces, meaningful community events, and opportunities to strengthen both physical and mental health.

Healthy Communities of Henry County has been revolutionizing the landscape and well-being of the residents of Henry County for 30 years. Founded in 1993, HCHC's roots stretch back to 1988, when a Kellogg Foundation grant and the vision of Mayor Bud Ayres set in motion a study of the county's health needs. From there, HCHC has blossomed into a vibrant organization, leaving its mark on every corner of the county.

At the helm of HCHC are a group of dedicated volunteers, serving on the board of directors. Their passion for the community shines through

in their efforts to create a healthier, happier Henry County. Under the guidance of its board, HCHC has spearheaded numerous initiatives.

Healthy Communities understands the intricate link between the environment and mental health, fostering a sense of connection and well-being through their open and free activities.

Jerry Cash, previous chair of the HCHC board, emphasized the various ways HCHC impacts the community, "We're more diversified than only trails. Although trails are our big program that we're proud of, we do a lot of things in the community related to the environment, and we partner with a lot of groups."

The Henry County Community Foundation has played a crucial role in HCHC's journey by supporting things like the Cool Climate Festival, the FUN Park playground construction, planting a butterfly garden at Memorial Park, and growing and sustaining trail systems. "We wouldn't be able to do all of this work without the help of the Foundation. We always need local support to get state-wide grants. Every trail has been impacted by the Foundation providing funding to help. It's impacting every corner of the county, from Honey Creek Trail and the FUN Park to the National Heritage Trail and Wolly Bear," reflected board member, Jeff Ray.

Each mile is paved with community support. Through Choose Henry grant cycles and the enduring support of Designated Funds, the Foundation's contributions have not only expanded access to outdoor recreation but also spurred economic development, attracting visitors and enriching the quality of life for all.



One of the designated funds, established by Frank Schwegman and his wife, Judy, was formed out of an interest in Healthy Communities and the hope to see the trails continue to thrive. At the start of local projects, Frank knew that the trails would need regular maintenance and care, and he wanted to ensure that they would receive the necessary funding for years and years to come.

Thanks to funds like this, the trails have been able to continue growing and providing important space for community members. During the difficult times of quarantine and social distancing, Beverly Matthews, HCHC Board Chair, saw how important these spaces are for not only physical but also mental health, "When everything was closed, people needed somewhere to go. I saw more people on the trails than ever before. They made more than just a physical impact. Being outside in these open, free spaces made a big difference for the mental health of the community. It wouldn't be possible without the funds at The Foundation."

Frank encourages people with passion to pursue lasting ways to support those things—like a fund at the The Foundation. "If you have a passion for something, then you can do this too! You can watch your fund grow and watch it help what you choose to set it up for. It helps strengthen the organization, and you can reap rewards just from giving and get the warm feeling that you're helping out." Individuals like Frank and Judy exemplify the power of giving that fuels the Foundation and builds up organizations like HCHC. Their foresight in establishing a designated fund ensures the long-term sustainability of the trail system, a crucial resource for physical and mental health.

The story of Healthy Communities is a reminder that a thriving community is built with the collective efforts of dedicated individuals and organizations, all working together towards a common goal. # A Heart for Children leads to Continued Support for Henry County Youth

ELSIE KLINE was a force for good in Henry County. Her story is a testament to the transformative power of one person's passionate heart.

Elsie's vision was to connect children with mentors, offering guidance, support, and a sense of belonging. In 1990, she planted the seeds of Big Brothers Big Sisters in Henry County, nurturing it from a budding idea into a vibrant program.

She spent much of her time and energy ensuring that kids in our community had strong mentoring relationships with caring adults. Her dedication was her driving force allowing for the program to match over 60 children with mentors, fostering friendships and opportunities beyond measure.

At the time a group of compassionate citizens had formed the Child Abuse Council. Through this connection, even more children were included in the Big Brothers Big Sisters program. The Big Brothers Big Sisters Program has evolved into what is now known as Believe and Achieve Mentoring (BAM).

Travis Cornett has been volunteering his time as a mentor with BAM for five years now. Feeling drawn to volunteer locally, he saw the need at BAM and thought it would be a good fit for him. And he was right.

Travis expressed gratitude for the program and the leadership, "It's a great group of people at BAM. They're supportive of the children and the volunteers. I can't say enough about the organization and the leadership."

Through the Lunch Buddy Program, Travis has mentored two students, one now in middle school, and one in elementary school. At first, he wasn't sure if 30 minutes would be enough time to connect. He shared, "But now I see how impactful that bit of time is. The conversations I've had with the kids are meaningful, and I can sense that they really look forward to that time and enjoy being with me. It's great to see the excitement on their faces when I show up. I've loved building relationships with them."

Thanks to Elsie's tireless efforts to create and sustain a strong program to support Henry County youth, mentors like Travis can make a lasting difference in the lives of young students.

But Elsie's impact didn't end there.

In 2003, when the community mourned her loss, they found a way to carry on her heart for Henry County's youth. Her friends Barbara Lacy,



Olene Veach, Susan Stamper, and Craig Bailey created the Elsie Kline Memorial Donor Advised Fund. "We decided we needed to do something to honor her," Olene stated. "Her biggest passion was helping kids. We wanted to do something that would help kids in all kinds of ways, to fill needs and provide for activities."

Their hope for the fund is to see it provide resources and opportunities for kids in the community, just as Elsie would have done.

And it has already begun to make an impact! With grants serving children with special needs, providing educational opportunities, and drug prevention programs, Elsie's fund is reaching children in the community.

The most recent grant was given to help two students from the New Castle Career Center attend an Education Careers Conference, opening doors to new possibilities in their chosen field.

Elsie Kline may be gone, but her impact is far from over. Through this fund, her spirit and dedication live on, shaping brighter futures for the children of Henry County, one opportunity at a time.

The Spark of an Unfinished Adventure

#### A scholarship born from loss, fueled by a spirit that could not be dimmed

The "Hilary Weimer Memorial Fund," serves as a meaningful memorial, established to carry on the legacy of a young woman named Hilary, whose life was cut much too short by a rare cancer.

While death took her physical presence, it couldn't touch the vibrant curiosity and love for adventure that defined her. Her spirit lives on through her scholarship and its recipients, individuals who, like Hilary, seek to explore the world, push boundaries, and learn with fervor.

A woman built of resilience and untamed curiosity, Hilary had a heart for adventure. With degrees in anthropology, folklore, and public administration, she was involved in a variety of internships around the United States. Experiencing the Council of State Governments in Washington D.C. and museum education in Wauconda, Illinois on to the Rocky Ridge Music Center in Estes Park, Colorado and so much more.

In her 29 years on this earth, she learned to play instruments like the flute, trumpet, piano, and organ. She was a member of several clubs and volunteered at many organizations, including the Henry County Community Foundation. She served on one of the first TASC (Teens About Serving the County) Committees. She was active in hiking, biking, traveling, snowboarding, and mountain climbing. Through it all, she didn't allow her cancer diagnosis to defeat her zest for life.

It's that vibrant ray of light in the face of the unimaginable that inspired the idea for the Hilary Weimer Scholarship Fund. Through profound grief and love, Hilary's parents, David and Jean Weimer, established a scholarship for Knightstown High School graduates.

During their junior or senior year of college, students may apply for this scholarship to aid in funding an internship, clinical, practicum, student teaching experience, or other similar program.

Understanding the need for internships to help build a successful portfolio and lead to employment, the Weimers sought to help make that possible for Knightstown students. "We wanted this scholarship to help those students seeking these opportunities. We have it geared for the third and fourth year of school to help students finish their degrees and gain more experience. Hilary took part in several internships and special programs, we thought this was a great way to remember her," recalled David.

This scholarship fund has already started the work it set out to do. With four students receiving help from the fund to extend their educational experiences, lives are being enriched while Hilary is being remembered.

The Hilary Weimer Memorial Fund stands as a tribute to the lasting impact

of a life well-lived. Though her time was short, Hilary continues to inspire future generations to embrace adventure and learn with unwavering passion. As students embark on internships and delve into their chosen fields, they leave their own mark on the world, adding to the ripple effect of positive change that extends far beyond the classroom. This fund is more than just a scholarship; it's a community of individuals driven by curiosity, resilience, and a love for life, ensuring that Hilary's legacy continues to illuminate the world forever.

# The Henry County County Cancer Society Fund

WHEN JUSTIN'S cancer started to take a toll on his mobility, he relied on the use of an electric wheelchair. Unfortunately, the wheelchair started to break down. He needed a new way to take care of things around the house, but most importantly, to allow him to spend more time outside with his son.

That's where the Henry County Cancer Society stepped in. The Henry County Cancer Society is a dedicated group of community members who stand with those battling cancer and offer a helping hand and listening ear.

Their story begins with Rosemary Muncy, a kind soul who founded the Cancer Society in the 1970s. Rosemary's love and care for those battling cancer lives on through a fund at the Henry County Community Foundation. This Field of Interest Fund that she created fuels the Society's mission, allowing them to reach those who can use a boost during a difficult time.

Leading the charge are five passionate individuals: Nancy Lewis, Wendy Padgett, Holly Guffey, Nora Rust, and Krista Gibson. Driven by a shared vision, they revived the Society, determined to make resources readily available. "We want the community to know they're not alone," says Nancy. "This fund is here to help." Their efforts go beyond financial assistance. They partner with other local agencies, ensuring holistic support for those facing cancer. They often help with things like gas cards for treatment trips or grocery assistance. When a single mom who was battling cancer could no longer work and was facing the risk of losing her car, the Cancer Society stepped in, helping her maintain transportation until she could return to work.

In Justin's case, they helped with finding an electric scooter. After spending time and energy trying to fix his wheelchair on his own, he realized he needed something different. Unsure if he could get help from the Cancer Society, Justin was surprised to receive a call from Nancy letting him know they'd be coming with a new electric scooter. Justin saw this as nothing short of a miracle, "God sent a blessing to help me out."

The Henry County Cancer Society Fund at the Foundation allows them to expand their reach. Their goal is to see the fund continue to grow, enabling them to alleviate the burdens of more cancer patients.

Thanks to their hard work and the power of endowment, cancer doesn't have to be fought alone. The work Rosemary began carries on through the Henry County Cancer Society, fueled by their endowment fund at HCCF. They stand ready, a helping hand of hope and support.

# Engineering a Difference In the Lives of Students

WITHIN THE WALLS of the New Castle Career Center, students from all over Henry County come to shape their futures.

In the engineering program, they are guided by the steady hand of David Allen, an engineering teacher with a passion for sparking "AHA!" moments. For Mr. Allen, teaching isn't just a job; it is an opportunity to ignite curious minds and watch them transform.

For over 20 years, Mr. Allen has worn many hats construction, enterprise, manufacturing, and even transportation and communication. Having spent 30 years before his teaching career working in the industry, Mr. Allen has a lot of experience and knowledge to offer his career center students.

When nominations opened for the Henry County Community Foundation's Teacher Excellence Award, three of Mr. Allen's students, Luke Joplin, Kenyan Troxel, and Ethan Werking, jumped at the chance to recognize him for his efforts in the classroom.

Ethan described a story of Mr. Allen's commitment and sacrifice to ensure the strength of the engineering program, "Since day one on the job, Mr. Allen has tried endlessly to find funding opportunities. Anywhere from Duke Energy cards, to creating products on C.A.D. and fabricating them to sell as a class at the New Castle Christmas street festivals. Around Christmas time, we held a fundraiser for our class. We sold decorations at the New Castle Christmas walk. I found Mr. Allen there selling items for our class in 20-degree weather by himself. I had to leave early, and he still sat out there for another two hours in the bitter cold for his students. He does so much for us that goes unnoticed it's hard not to just appreciate the opportunity of being in his class."

For Mr. Allen, the award isn't just a special honor; it is confirmation that he is doing the work he set out to do. He expressed "It verifies that I'm doing a good job. I sometimes see kids who have graduated, and they're doing what they learned in my class and using the lessons I've taught them. When you get an award for something like that, it shows how much of a difference you're making."

Mackenzie Jackson, the Career Center's Director, beamed with pride. "This award," she affirmed, "is great for Mr. Allen and the Career Center as a whole. It validates how wonderful the program is and what an excellent job the teacher is doing. For students from three different schools in different class sessions to nominate Mr. Allen, shows that this program is the right fit for some students. And that's great to see!"

The Teacher Excellence Award isn't just about one teacher; it is about the quiet heroes who walk among us, shaping the future with every lesson and every "AHA" moment. It is a testament to the power of a teacher to spark inspiration in the lives of their students.

The finalists for the Henry County **Community Foundation 2023 Lilly Endowment Community Scholarship** Program are Isabella Shelton, Hagerstown High School; Ryan Craig, Shenandoah High School; Lydia Harvey, New Castle High School; Stella Houchins, Tri High School; Jordan Weddle, Knightstown High School; Riley Webster, Union High School; and Garrett Grim, Blue River Valley High School.

The Lilly Endowment Community Scholarship Program is a highly competitive scholarship that provides full tuition, required fees, and a special allocation of up to \$900 per year for required books and equipment for four years of undergraduate study at any eligible Indiana public or private nonprofit college or university.

To be eligible for the scholarship, students must be graduating seniors from a local high school and must also be Henry County residents. Each high school nominates one student to represent their school in the scholarship selection process.

After careful evaluation, a scholarship committee made up of three judges from outside of Henry County interviews and selects one nominee and two alternates to forward to Independent Colleges of Indiana, Inc. (ICI) for the final selection of Henry County's Lilly Endowment Community Scholar.

The selected scholar will be notified in December and will have the opportunity to pursue their

academic dreams without the burden of financial constraints. The remaining finalists will each receive a one-time \$1,000 scholarship award from the Henry County Community Foundation for their outstanding achievements.

The Lilly Endowment Community Scholarship Program was established in 1998 with the aim of raising the level of educational attainment in Indiana and fostering a stronger connection between Indiana community foundations and their communities. Since its inception, the program has supported over 5,200 Indiana students with grants totaling in excess of \$505 million.

The Henry County Community Foundation is proud to support this remarkable scholarship program and to recognize the exceptional achievements of these seven outstanding students. We wish them all the best in their future endeavors.

# Myths of the Community Foundation

The Henry County Community Foundation is a great way for everyone to support the community and causes they love. However, there are common misconceptions that keep some from utilizing the Foundation to impact their community.



## Myth #1: I have to be a zillionaire to give to the Foundation.

Did you know 86% of donations to HCCF in 2023 were \$100 or less? Anyone can give to the Foundation and every donation makes an impact! If you give to the Choose Henry Flex Fund, your donation is pooled with others and the earnings provide grants to nonprofit organizations (see pages 4-5). You can also give to an existing fund to support a cause you care about.



## Myth #3: HCCF stockpiles the donations.

Not at all. We invest donations given to the Foundation because we believe in the long-term support of our community. Please refer to the graphic on this page that explains how your gifts will grow and provide more back into the community than you could even imagine! And, you might consider this—if you support a particular nonprofit with an annual gift, that support stops when you pass away. But, if you create a fund at HCCF, your donation continues forever, and your impact grows!




Myth #2: I can't start a fund at the Foundation because I am not a zillionaire.

No problem! You can build your fund over five years. With just \$83 a month, you can create a Designated Fund in just 5 years. Don't need birthday and Christmas presents? Others can give to help you create your fund as well. The minimum amount for an endowed fund is \$5,000 or \$25,000 depending on the fund type (learn more in the "your heart for the community" boxes at the end of each fund story).

Myth #4: I can only support local organizations with a fund at HCCF.

While most of our donors choose to support local causes, others support regional and national organizations. You can do that with the Foundation, too.
